## 2024 PROPANE FURNACE SAFE INSTALLATION REBATE APPLICATION

Rebates will be issued only for NEW furnaces that are at least 40,000 BTU and Energy Star rated. Boilers are considered a water heater. Only furnaces/heaters for heating a residence are eligible. Furnaces for commercial buildings, barns, garages, pool houses, sheds, etc. are not eligible for this rebate. Rebates will be paid until funds are depleted and will be granted on a first-come, first-serve basis. Submit this completed form with the

required documentation to the Michigan Propane Commission to the address provided (page 2). To apply for this rebate:

- 1. Complete this application in its entirety (2 pages). Please PRINT clearly.
- Include a copy of the paid receipt or invoice (must be purchased June 1, 2024 December 31, 2024. Must include information on the company installing the furnace. For furnaces purchased *before* October 1, 2024, rebates will not be issued after December 31, 2024. For furnaces purchased *on/after* October 1, 2024, rebates will not be issued after March 31, 2025.
- 3. Submit proof that the furnace is an Energy Star appliance. Proof should be a photo of the Energy Star label or Energy Star documentation provided with the furnace.
- 4. Submit proof of new propane line trenched or new tank set when switching to propane. Proof should be propane company work order or invoice.


